REBATE APPLICATION NOTES

- Electric Heat includes: Heat pumps and electric resistance heating systems.
- 2. A Certified Audit is conducted by a <u>participating BPI</u> or RESNET certified auditor. Audit Rebates to the Applicant (auditor or homeowner) for Option 3 or Option 4 Certified Audits are \$150 (\$75 after initial energy audit / \$75 <u>after the installation of at least one qualifying upgrade</u> within 12 months of the date of the Certified Audit). <u>Total of Audit Rebates cannot exceed cost of Audit.</u>
- **3.** Air Sealing 10% requires blower door pre- AND post-tests **OR** completion of substantial sealing as detailed by blower door pre-test and specification of work required to reach 10% reduction in air infiltration.
- **4.** Air Sealing 20% and 40% requires blower door pre- AND post-test.
- 5. Attic/Ceiling Insulation requires a starting "effective" value of less than or equal to R 24 (OR less than or equal to 8" of insulation). "Effective" R value considers framing members in the overall existing attic/ceiling R Value. A minimum of R 19 or 6" of insulation must be added. Must install a minimum of 500 sqft.
- **6.** Band Joist Insulation to qualify for this rebate the band joist must be air sealed and insulated with a minimum of R 10 value **OR** foam air seal plus existing R 10+ insulation. Minimum area must be 100 lineal ft OR entire available band joist area (whichever is smaller).
- **7.** Requires lapped and sealed vapor barrier on unfinished crawlspace floor if deficient or not existing.
- 8. Window Replacement Windows must be rated as ENERGY STAR for Northern Climate Zone and/or National Fenestration Council with a U value of .3 or less. Picture windows and sliding glass doors that are 30 sqft or larger count as 2 windows. To calculate window square feet: length (inches) x width (inches) divided by 144 = square feet of window.

- A Certified Audit must accompany OR be submitted prior and on file to claim the available higher level rebate levels.
- To receive OR assign Rebates, Applicant must have a valid legal signature on the Application and initials on the Terms and Conditions.

ELIGIBILITY

- DTE Energy (MichCon gas) must be your primary heating fuel supplier, or you must have ALL ELECTRIC HEAT with DTE Energy (Detroit Edison).
- DTE Energy account must be a Residential rate account in good standing at time of audit/installation.
- In order to submit Certified Audits, auditors must be BPI or RESNET certified for the current program year. Additionally, it is mandatory that prior to submitting Certified Audits, auditors register on dteenergy.com's Energy Efficiency Directory, attend/review a Program Training Session, sign a Participation Agreement, and a file a copy of BPI or RESNET certification with the Implementation Contractor (CLEAResult).
- Energy Audit Rebates and Weatherization Rebates are only available to structures built prior to Jan 1, 2008. Qualifying structures are: site-built single family residential homes and detached condominiums, connected housing (duplexes, flats, connected condominiums, townhouses, row houses, cooperatives) with: 3 stories or less, individual meters for natural gas and electricity, individual heat and domestic hot water (DHW) equipment, and individual entrances to each unit.
- Other types of multi-family buildings with: 3 stories or less, 4
 units or less, individual meters for natural gas and electricity,

NOTE: Blower door post-tests are typically included with Option 3 and 4 energy audits. Please discuss with your Certified Auditor.

All air sealing rebates require Certified Audit blower door pretest results. Air sealing 20% or 40% requires blower door post-test results.
